----- Tumble City Guidelines And Acknowledgement of Risk -----

Safety Rules:

1. All students need to store their belongings in the space provided.
2. Students MUST wait for their instructor to call them out onto the gym floor.
3. Parents, guests and siblings are NOT permitted on equipment and/or the gym floor. This is for the safety of the gymnasts and all others concerned.
4. All guests may watch from the viewing area. Children in viewing area are to be supervised at all times.
5. There is to be NO coaching from the sidelines as it is distracting to the student and coach, and could be dangerous. If a parent continues to interrupt class, they will be asked to wait in the lobby during workouts.

Enrollment: Fees are due prior to start of event/class. Students with due fees may be asked to sit out. Trial class fees are 25% of session cost and must be paid prior to trial class. Enrollment is limited and is first come first served. Events/classes may be limited to specific age groups and/or skill levels. Tumble City staff will determine eligibility.

Refunds: There are no refunds unless otherwise stated. Events may have a set deadline for refunds.

Punctuality: We ask that students arrive 5-10 minutes prior to event/class time. Every event/class begins with a warm-up which is important to reduce the risk of injuries. If student arrives late and misses any portion of the warm up, it will be up to the instructor if the student will be allowed into class.

Clothing: Each event/class may require different attire. NO STREET CLOTHES ARE ALLOWED; THIS INCLUDES DENIM. Tumble City may loan clothing to students for the day if their clothing is deemed inappropriate.

Miscellaneous:

1. ABSOLUTELY NO JEWELRY. Medical bracelets must be covered by a sports wrist band.
2. ALL hair must be pulled back away from the face and the shoulders.
3. No drinks and/or snacks in the gym area. Food and/or drinks are not allowed during workout, with the exception of water.
4. Tumble City is not responsible for lost or stolen items.

The undersigned acknowledges the above policies and agrees to abide by them. Further, the undersigned fully understand the inherent risk in the sport of gymnastics and agree to hold harmless Tumble City and its staff and owners, in the event of an accidental injury on the premises or during any event offsite. We further understand that Tumble City and the staff are not responsible for injury to the participant while practicing or performing apart from company and staff of Tumble City. In signing below, we also grant permission to the staff of Tumble City, to administer First Aid or enlist emergency professionals for treatment and/or transportation of the participant in case of an injury. In signing, we acknowledge that we have received, and understand the policies, as well as the guidelines of Tumble City and we agree to adhere to them. We fully understand that Tumble City has the right to refuse service to anyone, and if any breach of said policies is deemed by the management of Tumble City as serious enough for refusal of service or dismissal of student, the management has the right to execute disciplinary action.
